

RESOLUTION 22- 086

WHEREAS, the Dubuque County Compensation Board meets annually to recommend a compensation schedule for elected officials for the fiscal year immediately following, in accordance with Iowa Code Chapters 331.905 and 331.907, and;

WHEREAS, the Dubuque County Compensation Board met on December 6, 2021, and made the following salary recommendations for the elected officials for the fiscal year beginning July 1, 2022:

| <u>Elected Official</u> | <u>Current Salary</u> | <u>Proposed Increase</u> | <u>Recommended Salary</u> |
|-------------------------|-----------------------|--------------------------|---------------------------|
| Auditor | \$88,085.29 | 9% | \$96,012.96 |
| County Attorney | \$141,724.68 | 10% | \$155,897.15 |
| Recorder | \$85,620.51 | 10% | \$94,182.56 |
| Sheriff | \$122,698.77 | 15% | \$141,103.58 |
| Treasurer | \$86,855.89 | 10% | \$95,541.48 |
| Supervisors | \$52,432.84 | 6% | \$55,578.81 |

WHEREAS, the Dubuque County Board of Supervisors has reviewed the recommended compensation schedule and has accepted the salary recommendations to each elected official, except the Supervisors as pursuant to Iowa Code, Chapter 331.907(3), which allows the Board of Supervisors to adopt a decrease in compensation to Supervisors irrespective of the other approved changes in compensation paid to other elected county officials;
